All races start at the biathlon range. Give yourself plenty of time to ski the 1.5km out to the range prior to your race. Don't forget your trail pass.

Please Note: Trail fees are NOT included with race registrations.

All participants must have a valid Rendezvous Ski Trail pass in their possession.

Day passes can be purchased at the trailhead (you must have exact change).

*All passes available at Freeheel and Wheel, the West Yellowstone Chamber of Commerce, Hebgen Lake Ranger District. USFS personnel will be present to enforce the trail fee regulations. Daily passes are \$8 each, season passes are \$40 each, and family season passes are \$75. **You must have your trail pass prior to skiing out to the biathlon range.***
